# COO Education Sector: First Nation Post-Secondary Supports Costing Model

# **SUBMISSION INSTRUCTIONS**

You are invited to submit a proposal for a project by the Chiefs of Ontario to produce a costing model for post-secondary student supports and for First Nation administrators to support the learners.

#### **PURPOSE & BACKGROUND**

Chiefs of Ontario (COO) supports all First Nations in Ontario as they assert their sovereignty, jurisdiction, and their chosen expression of nationhood. The main objective of the Chiefs of Ontario office is to facilitate the discussion, planning, implementation and evaluation of all local and regional matters affecting the First Nations people of Ontario. Guided by the Chiefs in Assembly, COO upholds the self-determination efforts of the Anishinaabek, Mushkegowuk, Onkwehonwe, and Lenape Peoples in protecting and exercising their inherent and Treaty rights.

In 2023, the COO Education Sector produced a Post-Secondary Engagement Report that contains forty-one (41) broad regional recommendations. The recommendations are derived from community-level engagement that examined the current suite of Indigenous Service Canada's First Nation post-secondary education programs, the need of First Nation learners, and the need of First Nations to support their learners. The Report's recommendations are intended to be a starting point as First Nations explore developing post-secondary education models to meet the needs of their learners and communities.

A major theme in the report is the lack of funding to properly support students pursuing post-secondary education as well as First Nations and First Nation organizations that support the students' success in higher education. As the initial step to address the inadequacy, the COO Education Sector is seeking the services of a consultant to estimate adequate baseline costs of living supports for First Nation learners in Ontario attending post-secondary education as well as estimating costs for First Nation post-secondary education administrators to support the learners. This work will help inform the development of proposals for new regional models for post-secondary financial aid programs, policies and services for First Nation students in Ontario.

#### **OBJECTIVES**

The successful bidder for this project will produce a report that will:

Examine the cost of living increases over the last 10 years and estimate the increase for the
next 20 years, to describe the deficit of support to First Nation students in Ontario attending
post-secondary education and the Administrators that support them as well as to demonstrate
the need for increased funding

- Examine other provincial, federal, and international student support systems for rates, factors, calculations, innovative processes, and other relevant details that could apply to a First Nation student support costing model and or financial aid program
- Examine prevailing wage rates for relevant Post-Secondary Education support positions and other relevant administration budget items
- Use appropriate data and quantitative techniques to estimate a costing model of post-secondary student support for First Nation peoples in Ontario, that will include factors for, but not limited to, childcare, remote travel, connectivity, technology, living expenses (including food), with a clear discussion of assumptions and methodology.
  - This work will take into account all forms of post-secondary into consideration, including but not limited to, mainstream universities and colleges, and Indigenous Institutes.
  - This work will also take into consideration the cost of living in the cities, rural areas and First Nation communities where post-secondary institutes are located as well as the cost of travel to and from First Nation communities in Ontario and other urban or rural areas where First Nation learners reside
- Use appropriate data and quantitative techniques to estimate a costing model for First Nation
  post-secondary education departments in Ontario to adequately support First Nation learners
  attending post-secondary education, that will include but is not limited to, wages for appropriate
  personnel, professional development, capacity development, resource development, and a ratio
  of staff to learners to support.
- The models should be scalable to apply to variable locations of post-secondary institutes where learners are attending, the distance and forms of travel for the students to attend the institute of their choice for the student supports, and the location of the Administrator for the administration supports.
- Throughout the project, attention should be paid to data and other informational gaps, as well as
  differences between needs of learners from northern (including fly-in communities) and southern
  locations.

- Initial meeting to finalize methodologies, work schedules, and communication to be scheduled the week of May 27, 2024
- Interim report including detailed methodology between July 15-26, 2024
- Final report by: September 27, 2024

#### INTELLECTUAL PROPERTY:

The successful applicant will be required to transfer the copyright of the research and written materials to the Chiefs of Ontario. However, the name of the successful applicant will appear on the Final Report as the author of the Report. The Chiefs of Ontario will acknowledge the author of the report in any publication or distribution of the report. This acknowledgment shall appear at the beginning of the report in no less than 12 Times New Roman font. Further, any citation to this report shall acknowledge the author.

#### PROPOSALS MUST INCLUDE:

- A demonstration of your expertise in addressing issues related to research and analysis of First Nation post-secondary education, including the creation of costing models;
- A work plan in alignment with the project deliverables within the provided timeframe;
- A list of data sets and sources the applicant will be sourcing for the project;
- A proposed budget for the completion of the work with a budget schedule in alignment with the completion of each project deliverable for a maximum amount of \$40,000.
