Councillor Jessica Keeshig Martin stepped out.

Carlene – should have their own bank account, not in favour of \$50,000.00 or that they should receive the dollar amount for the Coordinator. If they don't reach their goal then they can come to Council

Arlene – if allocating funding, would like to see how much they have fundraised to date and what is in the budget. They said they were not coming to Council. Letter should be signed individually by the Group so that there is no backlash

Paul – feel the same way, we put money out for the Coordinator so that we have knowledge of what is going on, they want access to this and is not how it works, they said they didn't want any money from Chief and Council, that the committee was outside the realm of Chief and Council Norma – it is the 40th anniversary powwow, would be nice to support them in any way that is reasonable, believe they should be submitting a budget right now so we can understand the costs, agree with Carlene, once they understand their variance then come to us at that point. Table and chairs available, keep these available,

Mike — will prepare a summary of the bank account on what is available, giving access has been more tricky over the years, even to deposit, have to register account accessors. Trying to separate ourselves from any lottery and gaming activity, should set up their own account, will open up doors for them.

Arlene – thought they had this direction a while back Mike – they did

Councillor Nick Saunders entered meeting 9:48 a.m.

Anthony – did hear them say they weren't going to come for any funding, in hindsight they shouldn't have said that. If they have tickets available then start selling them now, problem with bank situation, should be leary of. Not willing to accept letter, it is not signed. Signature is required on anything brought forward. Send letter to Mr. Elliott and ask him to have letter signed. Always support powwow and happy with their initiatives, six months down the road they say this is what they are requesting.

Mike – have talked to them about applying for Coldwater

Carlene – TWS applications have not been applied for under HAAMB

Chief – erred when they didn't initially ask for a contribution, asking for money that was collected in previous years.

Ryan has been working with the Ontario of Ministry of Environment, Conservation and Parks to get funding to support fisheries data management and communication. Data management is needed for the Joint Council resolution from Oct 23, 2023 with respect to habitat condition monitoring. This is an important part of lake whitefish rehabilitation and the monitoring for Bruce C. Ryan was successful in obtaining the amount of \$134,000 over two years. This will support a master's student at Dr Joey Bernhardt's lab as well as communication tools for membership.

Employment expenses are all supported by revenues earned through the delivery of the tourism product and services. There are now two senior park maintenance attendants. There is a need for third position. The Park Budget can support this "new" position.

Lot 17 possible encroachment, foundation is over the line by 2 feet and possibly more than that on Lot 16. Recommendations – remove structure, redesign the lot, develop planning process not to build to close to property lines, standard setbacks; In order to prove they are not on their property we need a surveyor to come in.

Norma – we are still on a First Nation, shouldn't get wrapped up with all these lines, if it was another CP holder then we should get it fixed but because it is on band land and we have no policy, is partly our responsibility because we don't have that in place, keep the costs down, get a slap on the wrist, just leave it.

Paul – all through these years we have been trying to get people to follow rules and regulations, build inside your property lines, split the costs, move it, easiest fix is for her, has people coming in early February, don't agree with random pieces of property being allocated.

Jessica – hoping to build this building for a medical office, is there some type of agreement or contract that we can get in to with her, maybe the office is part of the Community.

Ogimaa - how much are we talking? Larissa - 3 acres

Ogimaa - this should be part of the conversation, should be fixed now

Mike - one option to keep costs down, do survey, confirm with landowner that they are over and do a land easement agreement.

Paul – other people who are over the line, we are telling them to move their property, in the past Council has said move your building.

Ogimaa - early in the game, have them do the fix or you are only going to be dealing with it down the road. Build on the property as surveyed.

Carlene - in favour of getting survey up and splitting the costs just to verify.

Wellness Centre Renovation Project 5g)— Cory Jones, Neegan present. William Jones present. Ready to Tender project, improvements are within the confines of the building and to improve accessibility, new stair case, Lift. Other main change, is the parking lot to make a level

entry into the basement. Changes to the interior where not documented. Cost estimate on proposed work - \$3.4 million which includes \$100,000.00 in contingency.

Ogimaa – drainage, we expended a lot to supposedly fix the drainage situation, porch was torn out, dug out, new big O put in, and made to believe that it resolved the situation, now hearing we

are doing it again

William – it was to take the water away, looking at more complex because of run off from bluff. Cory – work done serves the purpose, is helping, but talking more about the entirety of the site, Swails intercept the water, need to be re-established, blocked up, extending and deepening to help promote surface water movement around the site. Have to do because we are putting in a new septic, larger, and changes the site topography, also planning to fill in a large area at the top so that when you park there that you are not faced with a long progression. Improvements to make sure water stays away from the building.

Paul – what is the cost of that door, and digging out all that, seems beyond what Cory – don't have it specifically broken out, excavation, retaining walls, not expecting to run into any rock, foundation was built on the rock that was there, not expecting to go below foundation.

William - stuff excavating will be used in the front, more accessible for worker, talked about walk out for some time now.

Norma – why are we changing the septic bed, it was a residence before and now will just be offices

Cory – the loading will be different, hasn't been changed since it was built almost 30 years ago, expansion on the side have to remove the tanks, septic is due for replacement.

Ogimaa - putting a lift in, not an elevator, expand on

Cory – an elevator is a lot more robust in what you would experience in a high-rise building, maintenance and operating is quite expensive. Lift, would only be using four or five times a day, weight capacity 4 – 5 hundred pounds.

Ogimaa – is it practical, we have one in seniors building, spend more time fixing it then using it. William – seniors building wasn't installed properly. Less use on elevator with opening.

Cory - cost escalation for construction, work proposed has extended and expanded

Paul - where you getting the other 1 Million

Mike - Community wellbeing grant - 1.5; and NWMO

Paul - explored any other funding pots? Jordan's Principle?

Ogimaa – spent two years in design, when we start actual work, what is the schedule? Cory – our design was over one year, not two, my thoughts were that we are ready to go to Tender, can be posted next week, 4 week tender process from April 2025 to December 2025.

William - items not covered, can make provisional, fund later. They are asking us to identify money, GICB, 100% funding of 3 million

Mike - confirmation for solar was also received.

Paul - do follow up and get this person on board

Norma - can we not just say that the First Nation would come up with the money for the parking lot and the Arbour

Paul - Coldwater, August is deadline; usually about \$900,000 annually

Generator – could be secured by the old Water Treatment Centre to save costs

Food Bank – Community Centre is well ahead, design was from 2018, will be some change.

<u>Treaty 82 Claim</u>: Jaclyn McNamara – OKT present (virtual)

Meeting with Canada and Ontario starts at 10:00 a.m.; will be totally virtual due to weather.

Background – Unsold road allowances within the Treaty 82 Territory; was to sell for our benefit, unsold and unused so no actual roads on them. Meeting is about how to fulfil the Treaty obligation, asking for a lump sum amount of money for these road allowances, with the exception of some which may be returned in order to have access to shore.

Have been trying to get negotiations going on this for 20 years, Ontario is entering into exploratory discussions, has been very frustrating. Need to survey and figure out the exact locations, would be extremely expensive and time consuming and may not even been possible. Ontario has said it may not be practical, will take too long, too expensive. In 2021 got instructions to come up with a ball park acreage, and work with an evaluator, joint terms of reference, and see how much that land would be worth and use that to come up with some type of settlement.

Demonstrates that Ontario has been working and crafting this approach. We have been trying to come up with initial numbers, Ontario came back with a number of questions. 143.8 acres is the number, went back and forth with Ontario, Ontario agreed to provide parcel data compared to what Isaac had done so we are all working off the same, and cross check. Preliminary report once received will do a separate briefing.

This is the work that has been done. In the Fall of this year a new negotiator was appointed, this file has changed a number of negotiators over the years. Have met with "Tim" he has suggested that we may have to do all the detailed work that was suggested.

Norma - what is Canada estimating?

Jaclyn – we haven't received from either of them. If they had given us a number then we would have been able to provide specifics. Approach was to focus on Ontario, Ontario's liability is greater as they gave the unused road allowances to Municipalities for free. They disposed of the road allowances without getting any payment. Ontario wants Canada to be part of the discussions.

Norma – how are we going to start negotiations if we don't have the same information.

Jaclyn – give background information, where we are now, and that they should accept the analysis of Isaac. We need to be comfortable with what he has provided us before we say anything to Ontario and Canada. Would need to do the full survey work for any parcels that we want returned but you are not asking for any return of land.

Need to hear from Canada and Ontario on how they are actually going to move this along. Feels like they are trying to slow down the process, would like to come away with a commitment from them, timeline, next steps, but main goal is to get things moving again. (\$1-2.5 million or other model 1-10 million) Need to obtain expert advice on actual value.

Jessica - if we can get land back that's the approach that I would want to take, how much of that has been explored?

Neyaashiinigmiing Anishnaabekling, January 27, 2025

Jaclyn - Canada and Ontario have agreed that the lands are not being used as roads and not sold and no reason why they can't be returned, the survey is a big issue.

Jessica – is there a way to set up a process to be able to buy land when it is for sale and turn it into reserve?

Jaclyn – definitely an option. This land is not actually necessarily likely to go up for sale, access or abutting to shoreline and property owners use them.

Jessica - they are not private, or have cottages on them?

Jaclyn - some of them may

Ogimaa – we can take ownership of road shore allowances and control them, called negotiations so we can get the best deal that we can. Pay us per year for a lease. It adds value to their fee simple lands because it is on the bay.

Jaclyn – they haven't been coming to the Table with anything, things feel like they are a bit off the rails, can explore a few options, anything that gets into the main parcels may necessitate survey work, take many years and be quite expensive.

Some of the lands were given away, we know Nawash didn't get paid for those lands.

Paul – where is the Truth and Reconciliation in all of this, trying to live up to this, only when it suits them and when they try to get more mileage

Jaclyn – can put this to both of them, use the word reconciliation a lot, what is the path forward, they are not being a responsive partner

Paul - what are they bringing tomorrow?

Anthony - we walked out when they had nothing to offer. Should ask them what they thing Truth and Reconciliation means.

Ogimaa - opening question, what is your mandate?

What is a good outcome? Clarity on going forward, and receiving their mandate. Main goal is finding a path forward, a schedule of moving this along in a practical way, its been years. Paul – what about us going in with what we want? What is fair and reasonable? Norma – is the shoreline accessible from the road and what does that mean?

Jaclyn McNamara left meeting 2:00 p.m.

Update on Fishing Meeting 8d):

Meeting was on Fish Stocking with MNR present. But a Band member brought up that Council did not support a Fish processing plant

Jessica -- wasn't David Johnston Weiser hired to look at fish processing plant and the outcome was not to go ahead with it? Kolapore Springs, it fell through

Decline in whitefish, telling us that there is competition against the native fish
